

- Keep strictly pre-screening work;
- The good trend of paper processing time (within 40 days); and
- **Do more marketing promotions** (*contact conferences, set up Special Issues and some other ways*) to attract submissions. If you will attend conferences in 2018, please feel free to let me know. We can consider to cooperate with the conferences and may send you some journal flyers to distribute during the conferences.
